**Discussion Items:**

4. Report from Deputy Holmes - Deputy Holmes reported there were 25 cases for the month of March reported in Deweyville with 12 being extra patrols.

5. Carl Mackley - General Mgr, BRWCD - The district has the authority and responsibility to provide water to those counties that need water. There are currently 6 water systems around the BR Valley. There is a lot of growth and there will be a lot more. The BRWCD has made application (29-4020) to drill 1 test well on Forest Service ground at Flat Canyon this summer or fall. Drilling would be between 400-800 ft to reach bedrock aquifer. They have hired Bob Oaks, a retired ground water genius to help with this project. Testing would first establish a quantity of water, test pump it for time, and monitor for effect or impairment on current wells. Pipeline would follow the canal road north. There are no written agreements at this time with property owners seeking right of way. Mr. Mackley will address any questions or concerns at a public meeting held on May 9, 2019 at 8:00 PM. He would like to collect concerns or questions before this meeting to correctly address them.

6. Cemetery Prices - chart was provided showing current rates around the valley. Deweyville is definitely higher in their costs. It was presented that the cemetery cannot be a money maker and needs to be in line with other areas. Possible revised rate could be \$500 for resident/\$1000 for non-resident, with opening/closing cost being \$700 for either. This item will be revisited at a future meeting.

7. 2020 Budget - Mayor Kendrick asks for a motion to look over and tentatively approve the budget for 2020. There will be a work meeting to go over the budget on April 25, 2019 at 6:00 PM and encourages all departments to research what is needed in the future. Adopted budget deadline is coming up.
